INTERIM ORDER

Smt. Rajwati, New Bharat Colony, Kheri Kalan, Pani Plant Chandi Wala Baag Faridabad is consumer of DHBVN bearing account no. 5286137847 under SDO (OP) sub Divn., DHBVN, Kheri Kalan Faridabad and therefore, the Forum has jurisdiction to hear the complaint.

Complainant has filed the present complaint stating that she has received bill amounting to Rs. 8120283/-. Therefore, she has requested the Forum to redress his grievance.

The complaint was forwarded to the Nodal Officer for filing the written reply of the Nigam and both the parties were asked to appear before the Forum on 17.12.2021 at Faridabad for hearing of the case.

Proceedings were held on 17.12.2021. SDO as well as complainant were present. The SDO submitted that the case has been studied but required some more time to put up a comprehensive reply. Next date of hearing was fixed on 05.01.2022. No coercive action should be taken against the complainant till final decision of the case.

Proceedings were held on 02.02.2022. The SDO as well as the complainant were present. The SDO submitted replies vide memo no. 2006 dated 05.01.2022 and memo no. 2182 dated 02.02.2022 stating that bill has been corrected and that only an amount of Rs. 54376/- was payable. Copies of these replies have also been given to the complainant. The Forum directed the complainant to check up and submit his statement on the next date of hearing. Next date of hearing was fixed on 17.02.2022. No coercive action should be taken against the complainant till final decision of the case.

Proceedings were held on 17.02.2022. The SDO was present on video call whereas the complainant was present in person. The Forum directed the complainant to visit the subdivision to see for himself the record and submit his statement on the next date of hearing. Next date of hearing was fixed on 04.03.2022. No coercive action should be taken against the complainant till final decision of the case.

Proceedings were held on 08.03.2022. The SDO was present on video call whereas the complainant was present in person. The Forum again directed the complainant to visit the subdivision to see for himself the record and submit his statement on the next date of hearing. Next date of hearing was fixed on 21.03.2022. No coercive action should be taken against the complainant till final decision of the case.

Therefore, the Forum directed SDO to find out from records whether the reference of power factor of the meter prior to installation of AVON meter was available in record or not, and if available, to place it on record in the next hearing. Now to come up for hearing on 22.08.2022.

M/S Wireless Service, H. No. 1519, Near Hanuman Mandir, Sec-28, Faridabad is consumer of DHBVN bearing account no. 4609530000 under SDO (OP) Sub Divn., DHBVN, West Faridabad. The Forum has jurisdiction to hear the complaint.

Complainant has filed the present complaint stating that they have been issued excess bill in the month of 06/2021 for Rs. 1201225/- with sundry amount Rs. 1119707/-. The sundry amount charged through MDI penalty, but the amount of sundry is not justified. Therefore, they have requested the Forum to redress his grievance.

The complaint was forwarded to the Nodal Officer for filing the written reply of the Nigam and both the parties were asked to appear before the Forum on 17.02.2022 at Faridabad for hearing of the case.

Proceedings were held on 17.02.2022. The complainant as well as the SDO was present. The SDO submitted reply dated 17.02.2022 stating that the amount had been charged because the M&P team in their report dated June 2018 had shown excessively high MDI on the basis of which the penalty against excess MDI had been imposed. That the sanctioned load of the complainant was 14 kW. The Forum asked the SDO to submit complete details of the checking report along with MT1 report. Now to come up for hearing on 04.03.2022.
