INTERIM ORDER

M/S Savana Welfare Association, Flat no. 1106, T2- RPS Savana, Sec-88, Greater Faridabad is consumer of DHBVN bearing account no. under SDO (OP) Sub Divn., DHBVN, Kheri Kalan Faridabad and therefore, the Forum has jurisdiction to hear the complaint.

Complainant has filed the present complaint stating that the developer has not obtained the complete, adequate, desired connection from the Nigam because of which there are innumerable power outages, erratically voltage fluctuations resulting consumer electrical appliances damages and billing problems. Also during long power cuts the company is charging the huge amount per unit equivalent to Rs. 26.60 per unit +GST. Therefore, they have requested the Forum to redress their grievances.

The complaint was forwarded to the Nodal Officer for filing the written reply of the Nigam and both the parties were asked to appear before the Forum on 21.03.2022 at Faridabad for hearing of the case.

Proceedings were held on 21.03.2022. The complainant as well as the SDO was present. The SDO submitted that report will be placed on record on the next date of hearing. Now to come up for hearing on 07.04.2022.

Proceedings were held on 07.04.2022. The complainant as well as the SDO was present. The Forum directed SDO to issue notices to the developer M/S RPS telling them to implement provisions of single point regulations and to appear before the Forum on the next date of hearing, to submit para wise reply of the issues raised in the complaint

and to put up status report after verifying the facts at site. Now to come up for hearing on 20.04.2022.

Proceedings were held on 25.05.2022. The complainant, the developer as well as the SDO was present. The developer M/S RPS submitted their reply to the issues raised in the complaint. Copies of this reply was given to the complainant as well as the SDO. The complainant and the SDO were asked to make their respective submissions on the reply submitted by the developer. The SDO was also directed to conduct a survey of the society and verify the ground situation specially with reference to the issues raised in the complaint. Now to come up for hearing on 06.06.2022.

Proceedings were held on 06.06.2022. The SDO submitted reply to the reply submitted by M/S RPS on the last date of hearing. The SDO was also directed to conduct a survey of the society and verify the ground situation specially with reference to the issues raised in the complaint and to submit an independent report on the matter. Now to come up for hearing on 20.06.2022.

Proceedings were held on 06.07.2022. The complainant as well as the SDO were present. Clubbed with this case is the case number 4065 / 2022 filed by Sh. Sankar Kumar Dan, the matter being exactly same. The Forum observed that the SDO, even though directed during the last hearing to conduct a detailed survey to verify the facts on ground, did not submit any such report. The Forum again directed SDO to conduct a survey of the said society and verify in writing specifically the implementation of provisions of the Single Point Regulation 2020.

The Forum also asked M/S RPS to submit any further reply, if needed, specifically with reference to the reply submitted by DHBVN. Now to come up for hearing on 20.07.2022.

Proceedings were held on 20.07.2022. The complainant as well as the SDO were present. Clubbed with this case is the case number 4065 / 2022 filed by Sh. Sankar Kumar Dan, the matter being exactly same. The Forum observed that the SDO, even though directed during the last hearing to conduct a detailed survey to verify the facts on ground, did not submit any such report. The Forum again directed SDO to conduct a survey of the said society and verify in writing specifically the implementation of provisions of the Single Point Regulation 2020. The Forum also asked M/S RPS to submit any further reply, if needed, specifically with reference to the reply submitted by DHBVN. Now to come up for hearing on 03.08.2022.

Proceedings were held on 03.08.2022. The complainant as well as the SDO were present. Clubbed with this case is the case number 4065 / 2022 filed by Sh. Sankar Kumar Dan, the matter being exactly same. The Forum SDO and the advocate Mr. Raj Kumar Bhati appearing on behalf of DHBVN submitted a site survey report duly signed by the officers of DHBVN Kheri Kalan subdivision. Copies of this site survey report were given to the complainant as well as the representative of builder / developer M/S RPS. As demanded by the complainant, the copy of approved electrification plan was also handed over to him by the SDO. The Forum observed that the SDO in his report has brought some facts, which should be gone through the complainant as well as by M/S RPS. The Forum directed complainant as well as M/S RPS to

submit their statements on the site survey report latest by 18th August with copies to the SDO Kheri Kalan subdivision and that all parties should come on the next date of hearing duly prepared for arguments and also to submit their respective arguments in writing. Now to come up for hearing on 22.08.2022.

Proceedings were held on 22.08.2022 at Faridabad. The SDO was present on video call but the complainant requested for next date. Now to come up for hearing on 05.09.2022.

Proceedings were held on 08.09.2022 at Faridabad. The SDO was present on video call but the complainant requested for next date. Now to come up for hearing on 21.09.2022.

Proceedings were held on 21.09.2022 at Faridabad. The SDO as well as the complainant was present. Representative of M/S RPS was also present. The Forum observed that it was for the complainant now to submit a rejoinder so that arguments could be held. The complainant submitted that he would come prepared for arguments on the next date of hearing. The Forum directed all the parties to come prepared for arguments along with written copies of the argument on the next date of hearing. Now to come up for hearing on 07.10.2022.

Proceedings were held on 07.10.2022 at Faridabad. The SDO as well as the complainant was present. Representative of M/S RPS was also present. The complainant informed that they would require some more time to submit their rejoinder but at the same time informed that despite clear direction of Forum during last hearing, the subdivision has not conducted any survey of the area and the joint inspection

report as desired by the Forum could not be prepared. The Forum observed that the joint inspection should be carried out in a time bound manner. The Forum directed SDO, the complainant and M/S RPF to conduct a joint inspection between 12th to 14th October 2022 and submit the report to Forum latest by 18th October 2022 so that detailed arguments can be held on the next date of hearing and matter can be concluded. Now to come up for hearing on 21.10.2022.

INTERIM ORDER

M/S Sterling Tools Ltd., Plot no. 81, Sec-25, Faridabad is consumer of DHBVN bearing account no. 6207090000 under SDO (OP) S/U S/Divn., DHBVN, Ballabhgarh and therefore, the Forum has jurisdiction to hear the complaint.

Complainant has filed the present complaint stating that they had got increased their electricity CD from 1400 KVA to 1850 KVA and connected load from 1260 KW to 1665 KW on 24/12/2020. But till date this has not been updated in the DHBVN system and old CD and connected load is reflected on electricity bills. Therefore, he has requested the Forum to redress his grievance.

The complaint was forwarded to the Nodal Officer for filing the written reply of the Nigam and both the parties were asked to appear before the Forum on 06.05.2022 at Faridabad for hearing of the case.

Proceedings were held on 25.05.2022. The SDO as well as the complainant were present. The Forum directed SDO to submit complete record of the case by the next date of hearing. Now to come up for hearing on 06.06.2022.

Proceedings were held on 06.06.2022. The complainant as well as SDO were present. The complainant argued that when the money spent on erection of independent feeder was more than the service connection charges, then why he was being asked to deposit the service connection charges. The SDO argued that the sales circular of the Nigam says that irrespective of the fact that independent feeder had been erected by the complainant, service connection charges are leviable on extension of load. The Forum observed that there was some misconception and that SDO should submit all the facts in writing by the next date of hearing. Now to come up for hearing on 20.06.2022.

INTERIM ORDER

M/S United Oil Mill Machinery & Spares Pvt Ltd., 39 KM, Mathura Road, Balabgarh is consumer of DHBVN bearing account no. 1627001000 under SDO (OP) sub Divn., Ballabgarh, DHBVN, Faridabad and therefore, the Forum has jurisdiction to hear the complaint.

Complainant has filed the present complaint stating that their company was incorporated in 1968 and they have been paying security charges/ACD from 1968 onwards. The security charges/ACD deposited in the department from the year 2017 onwards. But as per law they are not being paid the interest on security charges/ACD and not being adjusted in the electricity bill. They are approaching the department regularly for calculating the interest and adjustment of the same, but the said amount has not been credited their electricity bill. They have requested the Forum to redress their complaint.

The complaint was forwarded to the Nodal Officer for filing the written reply of the Nigam and both the parties were asked to appear before the Forum on 06.06.2022 at Faridabad for hearing of the case.

Proceedings were held on 06.06.2022. The complainant as well as the SDO were present. The complainant submitted that they had paid an ACD of Rs. 166068/- in 1968 at the time of connection but against this amount, only an amount of Rs. 60300/- is shown as ACD in the billing system. Subsequently, they paid an ACD of Rs. 37677/- which is correctly reflected but the original difference of Rs. 166068 – Rs. 60300 still remains. The Forum directed SDO to check up from records the total amount of ACD with the Nigam. Now to come up for hearing on 20.06.2022.

Proceedings were held on 06.07.2022. The complainant as well as the SDO were present. The Forum again directed SDO to check up from records the total amount of ACD with the Nigam especially in light of the papers submitted by the complainant showing not only the interest paid but also the TDS deducted. Now to come up for hearing on 20.07.2022.

Proceedings were held on 20.07.2022. The complainant as well as the

Sh. Jagjit Mohan Vij, 1062, Sec-15, Faridabad is consumer of DHBVN bearing account no. 9391501000 under SDO (OP) sub Divn., East Faridabad, DHBVN, Faridabad and therefore, the Forum has jurisdiction to hear the complaint.

Complainant has filed the present complaint stating that he has received bills of solar net meter installed for solar system from 04/2018 to 04/2022 wherein DHBVN has raised bill for the excess import of units over export but when the export unit are higher than the import units DHBVN has not given any credit for the excess units exported to DHBVN. DHBVN is not settling the account as per sales circular no. D18/2016. He has requested the Forum to redress his complaint.

The complaint was forwarded to the Nodal Officer for filing the written reply of the Nigam and both the parties were asked to appear before the Forum on 06.06.2022 at Faridabad for hearing of the case.

Proceedings were held on 06.06.2022. The complainant as well as the SDO was present. The Forum directed SDO to put up facts of the case by the next date of hearing. Now to come up for hearing on 20.06.2022.

Proceedings were held on 06.07.2022. The complainant as well as the SDO was present. The SDO submitted reply vide memo no. 7223 dated 06.07.2022 but nothing come out of this reply. The Forum again directed SDO to put up all relevant facts of the case by the next date of hearing. Now to come up for hearing on 20.07.2022.

Proceedings were held on 20.07.2022. The complainant was not present but the SDO was present. The Forum again directed SDO to put up all relevant facts of the case including the solar generated units by the next date of hearing. Now to come up for hearing on 03.08.2022.

The Forum directs the subdivision to implement sales circular D-18/2016 and prepare on excel sheet the benefit admissible to the complainant by dividing the solar generated units, import and export units year wise from 01.08.2019 to 01.02.2022 and place the calculations before the Forum on the next date of hearing. Now to come up for hearing on 21.10.2022.

INTERIM ORDER

Sh. Mohd Tahir, C-35, Shiv Vihar, Part-2, Ismailpur, Faridabad is consumer of DHBVN bearing account no. 9930217006 under SDO (OP)Sub Divn., DHBVN, Tilpat. The Forum has jurisdiction to hear the complaint.

Complainant has filed the present complaint stating that he had received a bill in 07/2021 of Rs. 17752/- in which current bill was of Rs.1283/- with arrear amount of Rs.15960/- which he had paid on 20/07/2021. Then his meter was changed. After that in the month of 09/2021 he received a bill of Rs. 82358/-. He has made a complaint in the DHBVN office and inquired about this bill but no one was ready to heard his complaint and forced to deposit this amount. He has requested the Forum to redress his complaint.

The complaint was forwarded to the Nodal Officer for filing the written reply of the Nigam and both the parties were asked to appear before the Forum on 20.06.2022 at Faridabad for hearing of the case.

Proceedings were held on 06.07.2022 at Faridabad. The complainant as well as SDO were present. The SDO submitted reply vide memo no. 4633 dated 06.07.2022 giving some facts of the case. The Forum observed that the reply did not depict some vital facts of the case. The Forum also directed complainant to argue his case on the next date of hearing. Now to come up for hearing on 06.07.2022.

Proceedings were held on 20.07.2022 at Faridabad. The complainant as well as SDO were present. But the complainant came late and by that time, the SDO had left. So, arguments could not be held. The SDO submitted reply vide memo no. 4820 dated 20.07.2022 stating that Rs. 112380/- were correctly chargeable and that the complainant had not been paying his bills for more than a year now. INTERIM ORDER

Sh. Avtar Singh S/o Sh. Harpal Singh, R/o A-82, SGM Nagar, NIT Faridabad is consumer of DHBVN bearing account no. 5698730000 under SDO (OP) S/Divn., No. 4, DHBVN, Faridabad and therefore, the Forum has jurisdiction to hear the complaint.

Complainant has filed the present complaint stating that he has an industrial connection at his workshop. He is paying his bill regularly but suddenly he received electricity bill of a huge amount. He visited the S/divn. office where he was told that there is a reading difference between KVAh and KWAh but it was wrong because it was very much greater than his actual use. On making a complaint new meter was fixed and old meter was sent to lab for checking. After getting report from lab some units in new bill were subtracted which was also not the actual difference KVAh and KWAh? It is also mentioned here that his same power factor is working on the spot and the meter reading are approximately running same in the new meter till now. He has requested the Forum to redress his grievances.

The complaint was forwarded to the Nodal Officer for filing the written reply of the Nigam and both the parties were asked to appear before the Forum on 21.09.2022 at Faridabad for hearing of the case.

Proceedings were held on 21.09.2022 at Faridabad. The complainant as well as SDO was present. The SDO requested for another date to file the reply. Now to come up for hearing on 07.10.2022.

Proceedings were held on 07.10.2022 at Faridabad. The complainant as well as SDO was present. The SDO placed on record the consumption data which showed the difference in readings in kWh and kVAh. But at the same time the SDO informed that data downloading of the meter for the

period of dispute was not available. The Forum observed that SDO should personally take up the matter with M&P wing and try to find if the meter data could be traced out from the memory. The SDO requested for another date to file the facts. Now to come up for hearing on 21.10.2022

Complainant has filed the present complaint stating that they have received a document of amounting to Rs. 683250/- with M.F. penalty. They had received a bill of Rs. 581745/- in the month of May 2022 by charging wrong M.F., which they had already pay on 21/07/2022 to avoid disconnection of electricity supply. Due to this wrong calculation Rs. 476610/- needs to be refunded by DHBVN. They have requested the Forum to redress their complaint.

The complaint was forwarded to the Nodal Officer for filing the written reply of the Nigam and both the parties were asked to appear before the Forum on 22.08.2022 at Faridabad for hearing of the case.
