INTERIM ORDER

Case no.- 4740/2024

M/s EWRI Recyclers India Pvt. Ltd., M.no. 113, Killa no. 1977 and 22/16-1, Khewat/Khata no. 844-845/867, Deeghot, Tehsil Hodal, Palwal is consumer of DHBVN bearing account no. F47DA310027 under SDO (OP) S/Divn. Deeghot, DHBVN, Palwal and therefore, the Forum has jurisdiction to hear the complaint.

Complainant has filed the present complaint stating that he has purchase a property in open public auction from Central Bank of India and an outstanding at that property and DHBVN added lots of interest and penalty also on the same and there is some security deposit too with DHBVN. He has requested for waived off the same and allow for new connection. He has requested the Forum to redress his grievance.


The complaint was forwarded to the concerned SDO (OP) S/Divn. Deeghot, DHBVN, Palwal for filing the written reply of the Nigam and both the parties were asked to appear before the Forum on 02.08.2024 at Faridabad for hearing of the case.

Proceedings were held on 02.08.2024 at Faridabad. The SDO as well as representative of complainant both were present. Both the parties argued their case. The S/Divn. submitted his reply vide his office memo no. 666 dt. 02.08.2024 stating that:-

"This has reference to your good office letter memo no Ch-1/Forum-4740/GGN/2024 dated 24.0.2024 that the subject cited to submit the report/ version of the Nigam on the complaint under HERC regulation of HERC/48/2020/1st amendment /2022 dated 06.04.2022 within 7 days. The case listed for hearing on 02.08.2024 at 11:00 AM in the office of SE/OP Circle Sector-23 Faridabad. In the above case regard a firm named M/s Vishavash Tractor LTD, Address- Deeghot take an electricity connection (Consumer No. DA-31/0027). Further it is found the firm approved a loan on his property from Canara Bank. But due to some outstanding at the firm. After this the property of the firm is mortgage by the bank and sold by auction to M/s EWKI Recyclers India Pvt Ltd. At this time the M/s Vishavash Tractor LTD, Address- Deeghot has a defaulter an amount 389767/-, and now the firm M/s EWRI Recyclers India Pvt Ltd apply for a new connection in the reference of default property. But the file was cancelled by this office. After this M/s EWRI Recyclers India Pvt Ltd file a court case in the High Court (CWP No. 25460-2022). The case is pending in the High Court and next date of hearing of the case is dated 24.09.2024. - Therefore it is submitted that the further action will be taken by this office in the compliance of the next High Court's order. This is for your kind information and taking further necessary action please."

A copy of reply was given to the complainant. The complainant case was already pending in Hon'ble Punjab & Haryana High Court (CWP no. 25460-2022). The complainant submitted that he had withdrawn the complaint from the court. The Forum directed the complainant to provide documentary evidence of withdrawal letter from Court on complaint CWP no. 25460-2022 from Hon'ble court before next date failing

which his case will not be entertained in this Forum. The next date of hearing is fixed for 20.08.2024. Both the parties are directed to appear before the Forum on the next date i.e. 20.08.2024.
